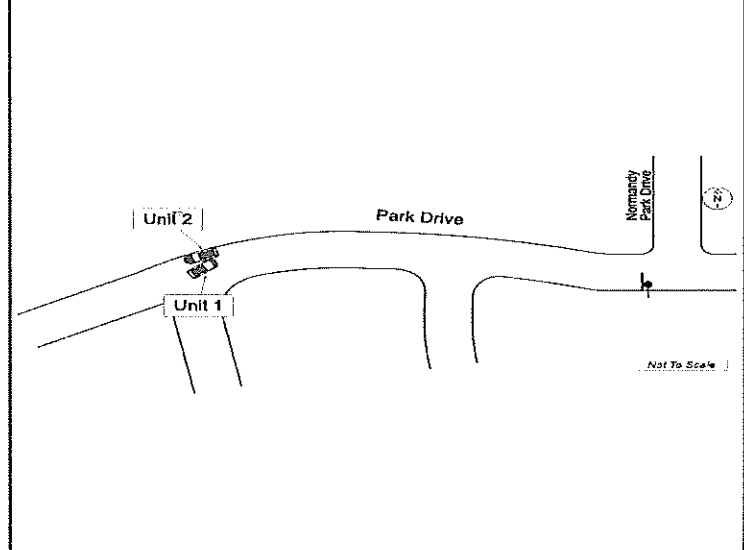

NARRATIVE

Unit 1 was traveling eastbound on Park Drive, while Unit 2 was traveling westbound on Park Drive. The driver of Unit 1 stated she was not paying attention and veered into the center of the roadway. Unit 1 struck the driver-side front tire of Unit 2 and continued along the driver's side to the rear tire before coming to a stop. Unit 2 sustained disabling damage to the driver-side rear wheel. Unit 1 sustained disabling damage to the driver-side front wheel and bumper. Unit 1 was towed by Jon's Towing. Unit 2 was towed by Lloyd's Towing at the owner's request. No injuries were reported. The driver of Unit 1 was issued a citation.
