NARRATIVE

Unit 1 was eastbound on Chippewa Road approaching the intersection of Wooster Pike. As Unit 1 attempted to slow down and stop for the stop sign, the driver of Unit 1 started to slide on the icy roadway. Instead of sliding into the intersection, the driver of Unit 1 veered off the right side of the roadway, striking the stop sign. Prior to striking the stop sign, Unit 1 ran over a metal post from a previously placed traffic sign, protruding from the ground approximately 6", which was located next to the stop sign. The driver then pulled into an adjacent business parking lot and contacted a wrecker. Upon my arrival, I observed both the front and rear passenger tires were flattened. This most likely occurred when Unit 1 ran over the previous sign post. The passenger side front fender, wheel well, and running board sustained moderate damage. Photographs were taken at the scene and no injuries were reported. The driver of Unit 1 was cited for failure to maintain reasonable control.
