NARRATIVE

Unit #1 was stopped in traffic eastbound and waiting to turn north onto Emerald Lakes Dr. from Sharon Copley Rd. Unit #2 was unable to stop in time and struck Unit #1 in the rear. Both units were able to pull onto Emerald Lakes Dr. and neither required a tow. None of the involved parties claimed injury at the scene. The juvenile driver of Unit #2 was cited for ACDA.

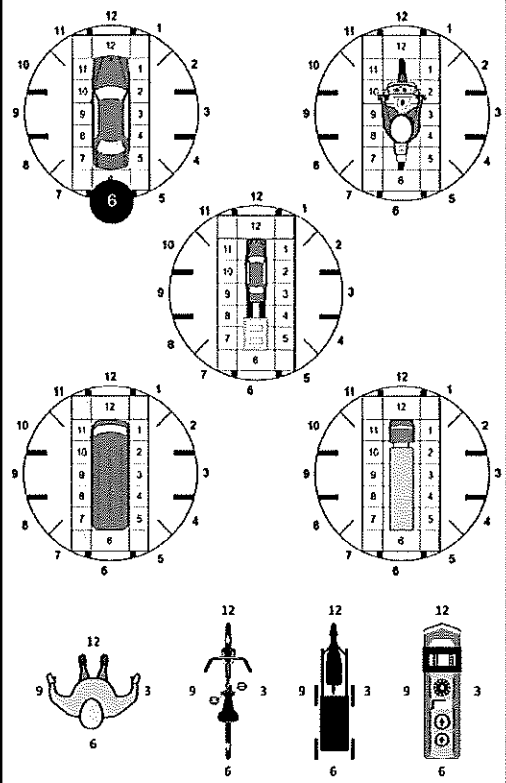
