

NARRATIVE Unit 1 was plowing a private driveway at 5211 Rustic Hills Drive. Unit 2 was traveling north on Rustic Hills Drive. The driver of Unit 1 stated he backed to the end of the driveway and was stopped, admitting his vehicle was slightly in the roadway. Unit 2 attempted to stop but, due to the snow-covered and slippery roadway, was unable to do so and struck the passenger-side rear bumper of Unit 1 with the passenger-side front bumper of Unit 2. After striking Unit 1, Unit 2 traveled off the left side of the roadway and sustained disabling damage. Jon's Towing responded and towed Unit 2 from the scene. There were conflicting statements regarding the position of Unit 1 in the roadway, and Unit 2 was no longer on scene upon my arrival.






