

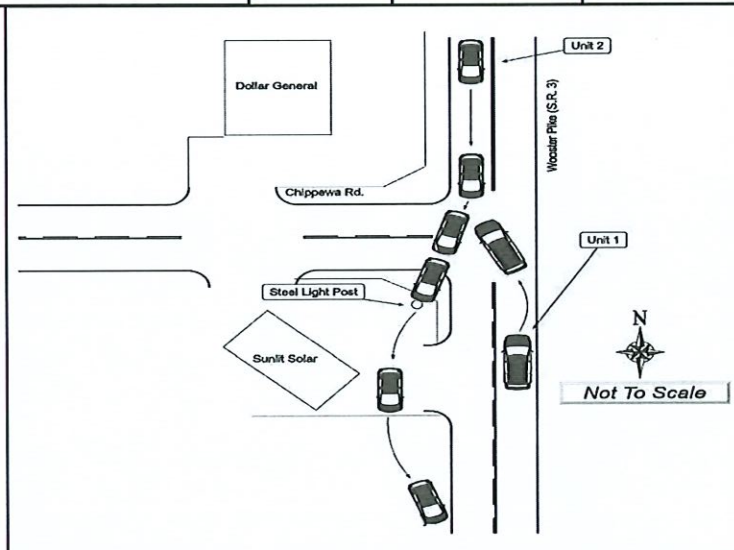

As Unit 2 approached the intersection, Unit 1, which was northbound on Wooster Pike, turned left onto Chippewa Rd. directly into the path of travel of Unit 2. In an attempt to avoid a head-on collision, the driver of Unit 2 swerved to the right and successfully avoided Unit 1. Unit 1 did not stop, and the make, model, and driver identity were initially unknown. Unit 2 continued into the parking lot of the business at the southwest corner of the intersection, striking a steel light post, removing it from its bolted position. Unit 2 pushed the light post to the opposite side of the parking lot where it then fell on the top of Unit 2 and separated from the vehicle. Unit 2 came to rest off the west side of the road, just south of the business. The driver suffered minor injuries related to airbag deployment and seatbelt abrasions. She was evaluated by EMS and released. Jon's Towing removed the vehicle from the scene due to disabling damage. The driver of Unit 2 was not cited due to her avoidance of a more serious traffic crash, which was corroborated by an independent witness. A follow up investigation allowed for the identification of Unit 1 and the driver, who has since been added.

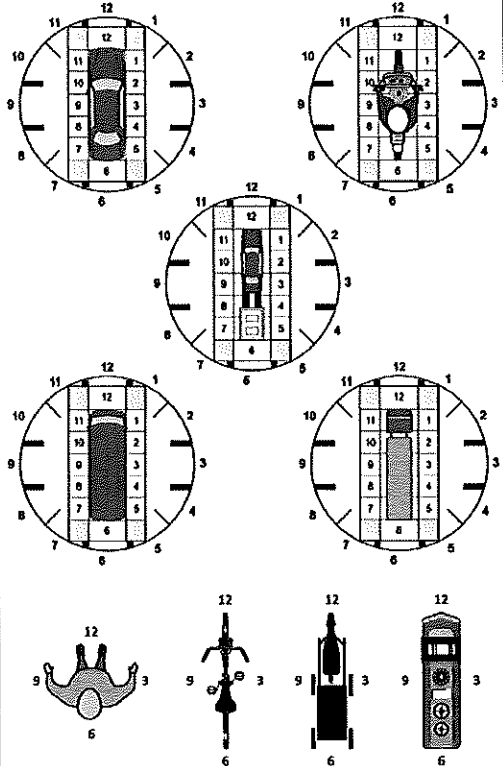

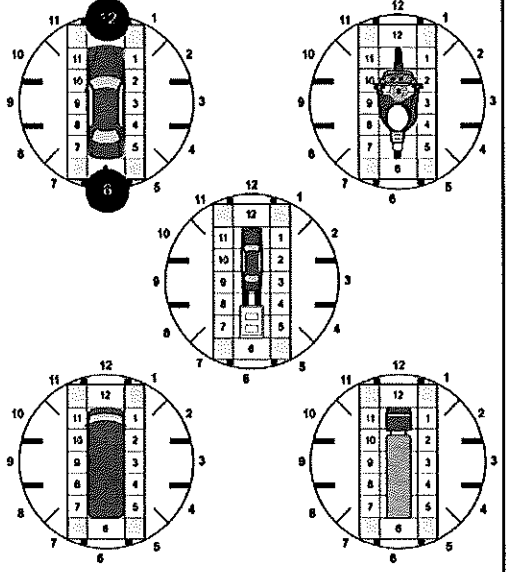

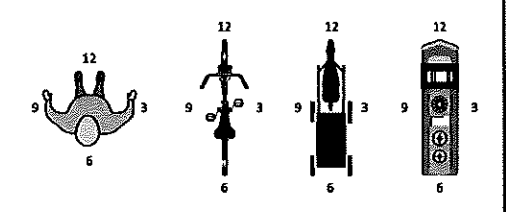
