Unit 2 was northbound on Wooster Pike, and Unit 1 turned directly in front of Unit 2, attempting to "beat" it. Unit 1 was unable to make it into the parking lot prior to being struck by Unit 2, which caused disabling damage to both vehicles. The passenger of Unit 2 suffered possible injury to her ribs, and the driver of Unit 1 was cited for failing to yield to oncoming traffic while turning left. Both vehicles were towed from the scene.

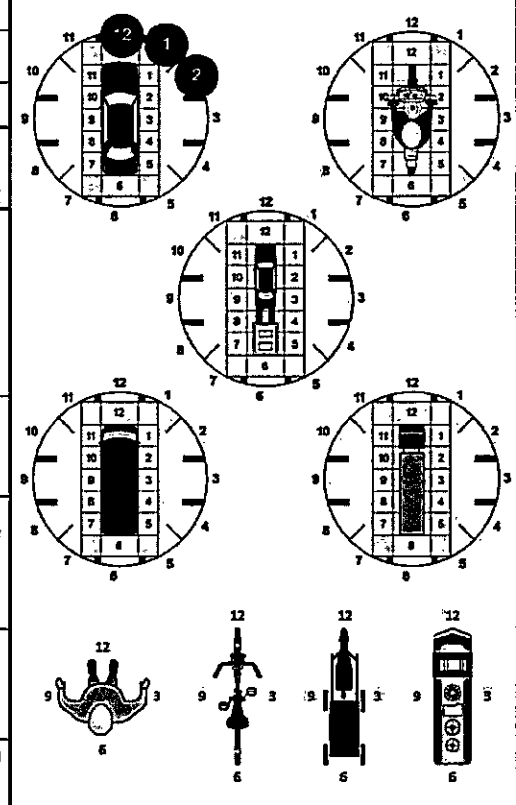
