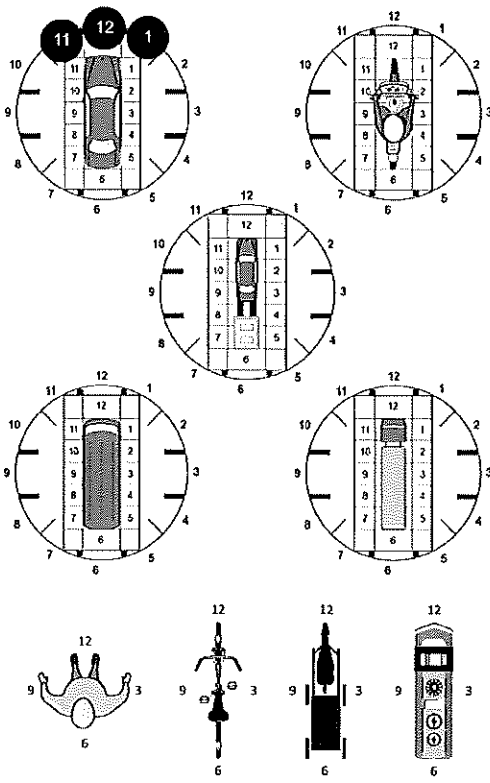

NARRATIVE Unit 1 was eastbound in the northernmost turn lane for Medina Road onto I-71 northbound when the driver averted her eyes into the interior of the vehicle and failed to observe Unit 2 slowing for stopped traffic, thus rear ending Unit 2. Unit 2 was able to be driven from the scene and initially complained of arm pain but then refused medical treatment from LST. Driver of Unit 1 stated she was uninjured and found to be driving under suspension and had active warrants. Unit 1 was subsequently towed from the scene by Jon's Towing.
