

NARRATIVE
Unit 1 was traveling eastbound in the 3800 block of East Smith Road. After exiting a curve, the driver lost control on the snow-packed and icy roadway. The vehicle drifted off the right side of the road and into a ditch, where the front passenger-side fender struck and leveled a road sign. World Truck Towing assisted in removing Unit 1 from the ditch. Unit 1 suffered functional damage and was able to be driven from the scene. No injuries reported and photographs were taken at the scene.
