Both units approached the four-way stop intersection at approximately the same time. According to dash camera video of Unit 1, Unit 2 entered the intersection first after stopping at the stop sign. As Unit 2 proceeded westbound through the intersection, Unit 1 entered the intersection from the north without yielding the right-of-way to Unit 2, who was already occupying the intersection. The front of Unit 1 struck the passenger side of Unit 2 in the middle of the southbound lane. The point of impact was located within the center of the southbound lane, consistent with Unit 2 already being established in the intersection at the time Unit 1 proceeded forward. | | | | | | | |
