## RESOLUTION NO. 021324. <u>O 2</u> EFFECTIVE IMMEDIATELY, PROHIBITING THE CULTIVATION, PROCESSING, AND RETAIL SALE OF "ADULT USE" CANNABIS WITHIN MONTVILLE TOWNSHIP.

WHEREAS, issue 2, now Chapter 3780 of the Ohio Revised Code, passed by a majority of Ohio voters and became effective December 7, 2023; and

WHEREAS, new Chapter 3780 of the Ohio Revised Code establishes a Division of Cannabis Control within the Department of Commerce, which shall provide for the licensure of "adult use" cannabis cultivators and processors, cannabis testing laboratories, and "adult use" dispensaries; and

WHEREAS, for the purposes of this Resolution, the definitions of "cultivators", "processors", and "adult use dispensaries" are given the same definitions as those found in Chapter 3780 of the Ohio Revised Code, which Chapter became effective December 7, 2023; and

WHEREAS, Section 3780.25 of the Ohio Revised Code authorizes a township board of trustees to adopt a resolution limiting the number of, entirely prohibiting, cultivators, processors, or "adult use" dispensaries licensed under Ohio Revised 'Code Chapter 3780 (collectively referred to as "adult use operators") within the unincorporated territory of the township; and

WHEREAS, the Board of Trustees of Montville Township finds it to be in the best interest of Montville Township to prohibit adult use cannabis operators within the unincorporated area of Montville Township; and

WHEREAS, pursuant to its authority under Section 3780.25 of the Ohio Revised Code, Montville Township wishes to prohibit adult use cannabis operators within the unincorporated area of Montville Township.

**NOW THEREFORE, BE IT RESOLVED,** by the Montville Township Board of Trustees, in Medina County, Ohio that:

**Section 1.** Pursuant to its powers under Ohio Revised Code Section 3780.25, the Montville Township Board of Trustees hereby prohibits adult use cannabis operators within the unincorporated area of Montville Township.

**Section 2.** The Fiscal Officer is hereby authorized and directed to mail a certified copy of this resolution to the Ohio Department of Commerce.
