## At Your Service ~

Lately, the Service Department has been finishing projects started in the Spring that were delayed by bad weather and lots of rain. At the same time, our crew are patching areas and repairing culverts on Good and Poe Roads until these entire roads can be paved next year. Ridgewood and East Poe will be paved and we will be chip sealing part of Good Road. We will also be doing some concrete repairs in the neighborhoods that have issues with the slabs and around

some of the catch basins.

We have been receiving many questions from residents regarding areas of township responsibility. Please be aware that we are not a city and that townships have different regulations. Some common clarifications are listed below:

Sidewalks and tree lawns are the homeowner's responsibility. Settling does occur over time. Trees belong to the property owner and we do not replace them.

Curbing and aesthetics are not a reason for repair or replacement.

Storm water drainage is a shared responsibility between the Township and Medina County.

## In the Zone ~

The Planning and Zoning
Office has seen an explosion of accessory structures
within the community during the first wave of the
pandemic. Many people,
forced to stay home, have
had the time to review

their yards and the possibilities of additional features. These include patios, pools (mostly inground), decks, fences and sheds. The idea of "staycations" has come to reality as our community moves forward through the COVID pandemic.

We believe that Montville Township attracts home buyers to our area because of the character and feel of the neighborhoods that we have created through well calculated zoning rules and regular enforcement. Recent inspections of several new accessory structures in the past months has identified other structures where required permits were not obtained, some present there for years and not noticed by the Zoning Office.

Please be aware that it is still the responsibility of the current owner to make sure these items are in compliance with the Montville Township Zoning Resolution.

We wish for all our residents and business partners to remain safe and healthy. The Planning and Zoning Office still remains open to the public, however, we do ask that social distancing be adhered to and the regulation of wearing a mask be incorporated as directed by Gov. Mike DeWine.



## **Medina County Fiber Network**

After delays due to the current pandemic and inability to get materials, the Medina County Fiber Network will start in Seville and Westfield Center using existing poles and then come into Montville Township.

Montville residents are now asked to shift from completing the survey to signing up. OnTrac is a CoVid sensitive contractor who will be approaching residents to score their "hook-up" from the street to each home. To reduce confusion to the community, they will be wearing Medina Fiber branded uniforms and driving their trucks and vans.

Fiber will bring us cable competition, lower prices/faster speed and better offerings. Fiber Network will provide education and a demo center in Seville at the Old Rittman Pharmacy building. Marketing will be "grass roots" and MVPs will be recruited to assist with signup. Coming will be new and helpful applications, i.e., Smart Homes, Telehealth, Waste Management and Wifi potential cameras. Installation to the house is free. They will be coming to Montville Township in the Fall and working through the Spring.



## **FirstEnergy Prepares Customers for Summer Heat**

- Consider investing in ENERGY STAR® appliances or heating, ventilating and air conditioning (HVAC) systems. FirstEnergy's utilities may offer rebates on these purchases and tax deductions may apply as well.
- Check air conditioner and furnace fan filters. Clogged filters waste energy and money by forcing HVAC systems to work harder than necessary.

What is a water footprint? **Sum total of every water decision you make daily,** obvious and not so obvious decisions. Care about your water usage. Be mindful.

Bathroom: Shower/tub? Usage at sink? Low-flow showerhead & toilets?

Laundry room: Washing machine or laundry mat?

Closet: Throw away old clothes or recycle?

Grocery store choices: Almonds or walnuts? Avocados? Chicken or beef?

## Do you know where the river flows?

What is a watershed? Everyone lives in a watershed! You have a watershed address. How do you figure it?



Your watershed address begins with the first named stream or lake that your property drains towards; name all the waterways. Keep following the flowing water until it ends at an Ocean.

Example, watershed address of Medina County Soil and Water Conservation District: Chippewa Creek Headwaters → Chippewa Lake → Chippewa Creek → Tuscarawas River → Muskingum River→ Ohio River → Mississippi River→ Gulf of Mexico → Atlantic Ocean

## Are we ever going to reopen???

Hello to all. Right now all of you may be asking that question, but know that we are also asking it! We are planning and taking extra steps to do all we can to ensure your safety. There will be a lot of different sched-



ules and procedures when we do eventually reopen. Know that we do not yet have permission from the State of Ohio to reopen any of our senior centers. Even when we do open, we will not be starting many activities right away. We will facilitate small group activities both in Medina (July/August) and in Brunswick (September). Food operations will not be reopened until at least September, and the date will be subject to change. When we finally get a reopen date for Medina, we will begin with a limited schedule of

activities in the dining room only and we may open two of the three pool tables. Everything will need a sign up, so you can't just pop into the agency.

Masks will have to be worn at all times. No congregate food or beverage so there will be no coffee station or drinking fountain, but you can fill up your water bottles or bring your own coffee. No food – yikes! Everything has to be distanced so no card groups or mah jongg can start, but exercise, yoga and tai chi will begin in the next few months. We will get used to things and slowly bring in more activities as the virus allows.

Know that we will continue to offer some classes and activities via Zoom and we continue to offer services over the phone or by appointment. We will continue to have new and different offerings so please check back often. Thank you so much for your patience, we are all in uncharted territory and we have all adapted. Stay safe and healthy, please wear your masks and get tested!
