We hope this will reduce the number of people getting lost on these 252 acres of parkland.

Austin Badger Fitness Park is getting upgrades to the existing mountain bike trail – ramps, banking, and other accountrements to facilitate the biking experience, orchestrated by Montville Township Police Officer Brett Robertson, paid for by donations with a "go fund me" page. They are set to begin these improvements this summer.

We recently received four Capital Budget Grants from the State of Ohio targeted to pay for bridge repairs and storm shelters in all three parks; repurposing of the old golf course halfway house into a field station in Aaron Smith for outdoor education and summer day camp programs; and an addition to the parking lot at Austin Badger. Our staff is completing the field station currently. Armstrong is supplying cable to this building as well as to the Blue Heron maintenance building so we can install cameras to maintain security at these locations.

The project was funded by an Ohio Capital Budget Grant and donations from the Ehrbar Angels Foundation, Medina County Law Enforcement, Medina County Career Center, Jessica Lynn Schaffer Memorial Fund, M-Star Foundation, Westfield Bank, the Ohio Department of Public Safety and Medina County Probate and Juvenile Court Judge Kevin Dunn. Take Control classes teach teen drivers about ways to react when encountering emergency braking, recovery from skids and off-road swerves to avoid collisions. Pipeline Safety: A Shared Responsibility



Data collected by the U.S. Department of Transportation reports pipelines are one of the safest ways to move energy resources like crude oil, natural gas and other petroleum products. Nexus is a partnership between Enbridge and Michigan Energy Company.

Enbridge now owns and operates a natural gas pipeline system in a small area of our township, and they maintain a Damage Prevention Program in accordance with state and federal guidelines. The purpose of this program is to prevent damage to their pipeline facilities from excavation activities such as digging, trenching, blasting, boring, tunneling, or backfilling or other activities such as heavy equipment crossing and storage on their right-ofway.

811, the national "call before you dig" number and **ClickBeforeYouDig.com** are free services designed to keep you safe when digging. Neighbors like you can help them maintain a safe, secure, and reliable pipeline system.
