RESOLUTION NO. 091916.01

**A RESOLUTION TO PROHIBIT LICENSING OF MEDICAL MARIJUANA
CULTIVATORS, PROCESSORS AND RETAIL DISPENSARIES IN
MONTVILLE TOWNSHIP**

WHEREAS, the legislature of the State of Ohio has adopted legislation that provides for medical marijuana to be cultivated, processed, and sold with a license obtained under Chapter 3796 of the Ohio Revised Code (R.C.); and

WHEREAS, R.C. 3796.29 permits a Board of Township Trustees to adopt a resolution to prohibit, or limit the number of, marijuana cultivators, processors, and dispensaries licensed within the unincorporated territory of the township; and

WHEREAS, Montville Township wishes to prohibit the cultivation, processing, and retail sale of medical marijuana within the unincorporated territory of the township.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Montville Township, Medina County, Ohio, two-thirds of all members elected thereto concurring that:


Section 1. The Trustees of Montville Township hereby prohibit licensing the cultivation, processing, and retail sale of medical marijuana within the unincorporated territory of the township pursuant to Subsection 3796.29 of the Ohio Revised Code.

Section 2. The Fiscal Officer is hereby authorized and directed to mail a certified copy of this resolution to the Ohio Department of Commerce.
